# Chairman's message

Coronavirus curtailed the Friends of Essex Churches Trust's activities during 2020 but within the restrictions that accompanied the medical emergency the Friends' committees and

volunteers continued to try to assist those who care for our churches and chapels. Grants have been awarded, work has been carried out and we were lucky to have been able to hold one, very successful, fundraiser in July. Reports herein from the Grants and Events Committees give more detail; our Treasurer is able to report that our funds are in good health. Unfortunately there were no Study Days and no Gepp Lecture but these will return as soon as conditions allow.

The difficulties of 2020 are not over and the consequences may be far reaching.

The enforced closure of places of worship and the older age group who make up many congregations, and who are more vulnerable to coronavirus, has reduced church attendance significantly; it is likely this has speeded up changes that were in train even without a global pandemic. Smaller, often rural, congregations are being whittled away and the task of caring for buildings is becoming more onerous.

Therefore the assistance provided by this charity will become more necessary in the coming years. The knowledge and skills that our volunteers and members have will become invaluable. Vital in both senses of the word: more necessary, and also more life-giving. The work of preservation is our duty and pleasure, our response both to the times we live in. difficult but by no means exceptionally so in a wider historical context, and our response to what we have inherited - the buildings, both magnificent and modest, that we worship in. I look forward to the unfolding year and hope we will see more of one another in 2021.

## Grants

It would be wrong to say that 2020 was 'business as usual' for the Grants Committee, but in the most importance sense it was: we offered grants totalling £147.850 to twenty-two churches in Essex and East London, detailed on the accompanying list. In addition to that, Wendens Ambo, St Mary the Virgin, received £2,500 towards the cost of installing a roof alarm, from a separate fund administered by us on behalf of the Allchurches Trust. The beneficiaries were all Church of England churches, despite the fact that we welcome and encourage applications from Roman Catholic and Independent (Nonconformist) churches.

In other respects 2020 was, of course, very different. We normally hold four meetings a year. The March meeting was held as usual, but the June meeting was cancelled, and the September and November meetings were held virtually. The lune meeting was Lance Lepper's last as chairman, after two years in the post, and we are all very grateful to him for his hard work in that role. I am pleased to say that he remains on the Committee. At the same time two long-standing members of the Committee retired: Jill Cole, who had been a member since 2013, and David Lodge. chairman from 2007 to 2018. We shall greatly miss the many years of accumulated knowledge and experience that they brought to the Committee.

The other big difference in the way we went about our business was that we stopped visiting the applicants. Although this has not mattered in the sense that applicants provide a great deal of written information, and most queries can be dealt with on the phone, it is an aspect of the Committee's work that members enjoy, and a personal visit can help to establish a long-term relationship with the churches that is important for both parties.

It is hard at this stage to know how things will work out during the course of 2021. Nationally, it is already apparent that parish giving was considerably reduced in 2020, and this will have an effect on how much can be spent on church repairs and improvements in the coming months. There is also a growing feeling, which may turn out to be unjustified, that many churches which have closed their doors during the pandemic may not reopen. Churches across the country were major beneficiaries of the Culture Recovery Fund in 2020, to the tune of £30m, but this was spread between 227 institutions and in the Diocese of Chelmsford only three churches received grants (Brentwood, St Thomas, £107,000; Leytonstone, St Andrew, £3,400; Walthamstow, St Peter-in-the Forest, £42,000). If parishes are in a position to embark on new projects - and repairs are always necessary, even if improvements can be postponed - the Friends will be needed

more than ever, working in conjunction with the regular national grant-making bodies such as the National Churches Trust, the Allchurches Trust, and the Garfield Weston Foundation.

A couple of 2020's grants, to Jaywick, St Christopher, and Nazeing, St Giles, demonstrate that, unlike some other county trusts, we do not confine ourselves to helping listed buildings or buildings over a certain age. Both these churches, 87 and 56 years old respectively, look more like church halls than churches, and they function as both. Our priority must be to keep church buildings operating not just as places of worship but also, increasingly, as community buildings in the widest sense. That means keeping them in good repair, wind- and watertight, but also fully accessible and, as far as is feasible, comfortable and with up-to-date facilities. Our communities need our churches, and our churches need us.

# Ride+Stride 2020

We would all have liked to be out-of-doors and enjoying the early autumn sunshine on the second Saturday in September 2020. After weeks of confinement for all, anxiety for many and inactivity for some, a bracing bike ride should have been exactly what the doctors would have ordered. Especially in aid of the county's magnificent churches, most of which had been sadly closed since Lent.

When the pandemic struck in March, everyone hoped that its passage would be swift, and that life would quickly return to normal after a short period of confinement. I was shocked to find churches being closed at a time when spiritual guidance was urgently required, but worldwide the pressure was to discourage places where people might congregate and thereby pass on the virus. In the late Spring, it seemed that the statistics were becoming more favourable, and the hope grew that by the time of the Ride+Stride, we would be back on our bikes. Nationally, it was accepted that most counties would struggle to organise the usual Ride+Stride, so help was offered by the National Churches Trust to the organisers.

Sadly, we now know that it is taking a lot longer to get on top of this menace than appeared to be the case back in June and July. Although I received a clear message that many of Essex's regular cyclists were keen to shake off the sluggishness of the

weeks when they had been prohibited from going out, I received a much more cautious message from the various R+S co-ordinators, churchwardens and vicars. There was an understandable concern that a stream of athletes would result in the need for an extensive cleansing operation, on the day before many of them expected to be tentatively welcoming a congregation for a service. Without a clear indication about which churches would be open (and, better still, able to welcome riders and striders in the usual way), it wasn't possible to advertise the information needed to enable participants to plan routes. Many of our regulars need to know where they can reliably plan for a 'pit-stop', and it was pointed out to me that a Ride+Stride without open churches would merely be another bicycle ride. The Ride+Stride National committee left the final decision to individual counties.

Although the Covid statistics for Essex looked better than many other parts of

the country, Southend and the East End of London (which falls into our area) were a significant cause for concern, and the primary factor in the decision not to proceed. Several die-hards (including me!) did elect to take to their bikes on I 2th September 2020, probably encouraged by the decisions of neighbouring counties like Cambridgeshire, Hertfordshire and Suffolk to take part, and it was, inevitably, a pleasant day for cycling.

However, we must try to encourage more churches to open their doors in 2021 if the Ride+Stride is to return to its significance of earlier years. To this end, I am trying to contact as many churches up-and-down the county (of all Christian denominations) as possible to discover what reassurance is needed to enable them to be able to greet Riders and Striders. It is becoming sadly apparent that many of the county's churches will be in need of funds when the authorities finally allow them to reopen - what better way of getting this underway than having an open day on I I th September 2021? By then, we will know the effectiveness of the vaccines. and should also be able to ensure that the guidelines in respect of hygiene and cleanliness can be complied with by those entering the churches. Ventilation should also not be a problem.

I can't end this report without a mention of the Rev Tim Hardingham, associate priest

of Wendens Ambo, St Mary the Virgin, for many years a loyal supporter of Ride+Stride. He participated this year, as usual, bicycling mainly across the border in Cambridgeshire. Sadly, on 25th October 2020, he was killed in a road accident near to his home, while cycling with his wife and two children. He will be sadly missed by all who knew him.

## **Treasurer's report**

The Covid-19 pandemic had, not unexpectedly, an adverse effect upon the Trust's finances for 2020. Fund-raising produced £39,200 less than in 2019 with donations reduced by £9,500. Fortunately legacies increased by £23,100 to £85,500 – one producing £74,000 as an initial payment on account arising from a property sale.

Grants to churches for building works were just as numerous. The combined total of Repair

and Improvement grants was slightly lower by  $\pounds 19,200$  to  $\pounds 147,000$ . In addition, a further grant was made towards the cost of installing a roof alarm and that was paid over.

My thanks go to everyone who helped to provide funds in any of the various ways that were available.
